**FOSTER AGREEMENT** rev 8/2017

By signing this agreement, I understand and agree to the following: I agree to abide by the policies and procedures of Evergreen Animal Protective League (EAPL). As a foster parent, I will temporarily take an animal into my home and give EAPL a character assessment of the animal.

I understand that EAPL pays/reimburses for approved medical attention and approved food. Many times the animal will need to be spayed/neutered and vaccinated. We typically ask the foster to arrange a vet appointment with one of our approved vets and make sure the animal neutered/spayed and are up-to-date on vaccinations. EAPL will cover the costs. I understand if I want my foster animal to have anything special, that EAPL normally has donated items that they can provide. However, I am welcome to donate any supplies for my foster animal and it would (of course) be a donation.

I understand if the animal is not house trained, EAPL would like me to do training to help make the pet more adoptable. I understand that most of the animals will be coming from shelters. I understand that EAPL asks that I be patient with them and try to help them transition and prepare for their new families. I agree to help EAPL try to figure out what the animal may need to move forward and together EAPL and I can work on a plan to make it happen.

I understand that I can advise EAPL the size, breed, age, etc. and EAPL will try to match me with my preference of a foster animal. I understand that if I want to adopt my foster animal that all the normal adoption fees will apply. I understand that there is no guarantee on how long an animal will be with me, but that EAPL will do everything possible to get the animal into a permanent home. EAPL advertises/lists their available animals on [www.PetFinder.com](http://www.PetFinder.com) along with 30 other national websites, community poster boards and host various community adoption events.

We ask that you truly think about fostering before you sign up our foster program agreement. Most of the time when we bring in an animal to a foster home, we have NO OTHER place to place them. Please keep in mind that it will take us some time to find another foster home if you change your mind about being a foster home.

I agree to hold the animal(s) for the length of required foster care (until adoption). At no time shall any animal(s) be transferred to any other rescue, shelter or home without the knowledge and approval of EAPL All foster to adopt pet(s) are the sole legal property of EAPL until the adoption is finalized. I agree to be personally responsible for the humane care, treatment and control of the animal(s) in my care until adopted. Do not take you brand new foster dog out until you know the dog, the temperament, and the dog knows you. Remember they just came out of a shelter in most cases and they are confused and scared. Give them time to adjust and settle. Introduce your new foster dogs as you would any new pet into your home, slowly and carefully. I agree not to hold Evergreen Animal Protective League (EAPL), its volunteers or board members responsible for any damages resulting from scratches, bites, pet fights, or any material damage. You are accepting a foster animal that we do not know the history of. They are shelter animals; usually they are strays/owner surrenders who are being saved from euthanizing. We have not met the animals prior to them being transferred to EAPL. In the event that an animal(s) shows signs of illness, I will notify EAPL at 303-674-6442. I will only seek medical treatment for an animal(s) when authorized by EAPL. I will go to the vet that is specified by EAPL with the authorization of the organization.

I understand and agree to adhere to all relevant zoning and animal control codes and ordinances, whether local, county, or state.
